4. Details of our assessment

A notification has been received by Natural Resources Wales that an Operator Self Monitoring sample taken by Dwr Cymru at Rhydwyn sewage works on the 15th of October 2021 had a Biochemical Oxygen Demand of 23mg/l. The permit limit is 18mg/l.

It is understood that this is the first exceedance in a year and therefore under the look up table procedure isn't a permit failure / breach for the year.

However this CAR form is being sent to record this exceedance and to ask two basic questions:

1. Why did this exceedance happen?
2. What steps are being taken to prevent a re-occurrence?

Your answers to these questions would be appreciated.
