4. Details of our assessment

The meeting took place at the IQE offices, Imperial Park, Celtic Way, Newport and included the following personnel:

The agenda for the meeting had been agreed beforehand which focussed on compliance with IQE's permit, reference EPR/AB3893FZ, and included a site tour of the facility.

The meeting opened with introductions, roles and responsibilities and a business update from IQE. IQE referenced Sustainable Management of Natural Resources (SMNR) initiatives and are encouraged to report these to NRW as part of its end of year performance review.

With regards to the permit and the improvement programme requirements set out in Table S1.3, AP confirmed that the plant serving emission point A4 has not yet been commissioned. IQE is aware of its responsibility to fully comply with IC3 by carrying out emission testing of arsine during the commissioning and to follow the same procedure as it did previously for emission point A1.

During the tour of the facility, NRW officers were made aware of back-up generators on site.

Action 1: In light of the Medium Combustion Plant and Specified Generator Regulations that came into force in 2018 [The Environmental Permitting \(England and Wales\) \(Amendment\) Regulations 2018 \(legislation.gov.uk\)](#) and in order to establish the need for regulatory compliance for back-up generators, IQE shall submit to NRW within 1 month from the date of this CAR form, details of all back-up generators at the site to include number, size, fuel type and when they came into operation.

With regards to the reporting paragraph 4.2.2 (b) '*the annual production / treatment data set in Schedule 4 tables S4.2*', IQE confirmed by email on 1st October, 2021, that wafers produced are recorded in total Kg used (weight), Sq Inches used & metres Sq used and that they will continue to report to NRW in Kg.
