4. Details of our assessment

Kim Jones and Ffion Quan, Mid Wales Waste Officers undertook a pre-arranged site inspection at Blacksmiths Garage, Gwystre.

The previous site inspection was on 4 June 2019 and Mr Stephens confirmed that no waste had entered the site since this time and that approximately 20 cars have been removed.

The layby in front of the house only had 4 vehicles and Mr Stephens stated that none of them were waste.

It was also explained that 6 vehicles had been sold and were awaiting collection.

The driveway to the rear of the house has also been cleared and 4 large trees in this area are due to be felled on 22nd Dec 2021.



We were unable to enter the land behind the house and confirm how many vehicles are on site as Mr Stephens has not been into this area for several years and has mislaid the key to the gate. This also confirms that no new vehicles have been brought onto site.

We briefly discussed surrendering the permit. Having briefly read the guidance on surrender it appears a site condition report will be required and this cannot be carried out until there is sufficient access to the yard and all the end of life vehicles have been removed.

During this site visit the officers detected no odours or noise. There was no visual evidence of pests, dust or debris on the road.

Mr Stephens has agreed to continue to remove waste from the site and is envisaged that access to the yard will be soon when the sold vehicles are collected.
