4. Details of our assessment

This CAR form covers the unannounced visit which took place on the morning of the 7th July 2021. Officers had already walked the perimeter of the site prior to this visit and had spoken with the nearby reporter. At the time there was no noise noted off-site which was deemed to be classed as a nuisance.

Below points were discussed during the visit.

It was good to see signage around the site requesting employees work in a manner to prevent noise nuisance, however can you re-iterate with all employees or contractors/drivers etc the importance of operating in a manner which reduces any potential noise emanating from the site such as beeping, revving of engines, or shouting. If this can also be re-iterated to the 'shunt' driver as discussed.

In terms of the other potential noise sources, the compressor/fan unit which was 'squeaking' and it was explained a recent service found issues – if you can please keep me updated as to when the replacement is likely (you gave a 3 week timeframe but explained this could be delayed) and also provide information on the replacement by the 22nd November at the latest.

We discussed the potential for additional signage to the compressor house door to ensure that this is not left open, especially on the weekend when maintenance or security are on site. Signage by the trailer parking re-iterating that all units must be on electric in that area may also be worth considering.

In terms of the refrigerated trailers at the front of the yard, the difference in the noise when they are running on diesel or electric is noticeable on and off site. When running on diesel it was clearly audible off site. I would ask that you review your Noise Management Plan and ensure a written procedure for scenarios when trailers may be on diesel is included and that relevant employees are aware of what action to take in that instance. If you could do this and feedback to myself by the 22nd November at the latest.

A number of flies were seen at the reporters property when we visited them this morning, however after having being on site and reviewing your spraying frequency and checking the fly boards I am satisfied that you are managing the flies as required under your pest control plan and that the flies are unlikely to be as a result of operations on your site.
