4. Details of our assessment

Officers carried out an unannounced site boundary visit on the 12th October 2021 at approx. 20:30hrs in response to recent noise reports.

Officers drove past the entrance and then down the lane to the north of the site (between the site and the reporters property. Officers then walked the length of the northern / north western boundary of the site.

No noise was noted that was deemed as intrusive off-site. The Officers could hear the low hum of the electric trailers but could not detect any diesel trailers running and the site seemed quiet.

No non-compliances noted in relation to noise on this occasion.
