4. Details of our assessment

Officers met the company Director on site.

The Combined Heat and Power (CHP) unit was shut down on 26.09.21 to allow maintenance to be carried out. At the time of the inspection, the CHP unit was not operational.


The CHP fuel which was deemed unsuitable during the site inspection carried out on 20.09.21 (contained contaminants including bits of plastics, rubber and electrical wires) was stored in an outside bay and this bay had been cordoned off.

This waste was removed from site on 11.10.21 and taken to a site authorised to accept it. Completed waste transfer notes and photographs were provided to NRW.

Officers observed that the pallets of wrapped product had been removed from the NB4 bunker and this area was now empty. The operator intends to store the CHP fuel mix in here following CHP restart.

Officers were shown a range of data from the Supervisory Control and Data Acquisition (SCADA) system and site production logs between 14.09.21-15.09.21. This data indicates that the CHP unit was operational despite an issue with the fabric bag filter abatement system.

This issue is being investigated separately and an Environmental Permitting (England and Wales) Regulations 2016 regulation 61(1) statutory notice requiring information has been served on the operator.
