## 3. What will happen next?

**Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecutions and/or suspension or revocation of your permit.**

**You are non-compliant with your permit. We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.**

## 4. Details of our assessment

Officers were accompanied on this inspection by a representative from Denbighshire County Council.

No odours or smoke were detected during an offsite assessment carried out by officers at the entrance to the Glasdir housing estate immediately before the site inspection.

The Combined Heat and Power (CHP) unit was operational at the time of the inspection. The plume appeared grey in colour and was dispersing in the opposite direction to the Glasdir housing estate. There were no odours detected on site.

The fuel for the CHP unit was stored uncovered in bays outside. The fuel consisted of woodchips, biomass and plant matter. The fuel appeared visually compliant and there was no evidence of contamination. The fuel felt dry to the touch.

The fuel mix observed on the walking floor of the CHP unit was consistent with the fuel stockpiled outside. This fuel was visually compliant and felt dry to the touch.

At the time of the inspection, fuel for the CHP was being mixed and stored outside. With reference to the site Environmental Management System (EMS), specifically Site Operating Procedure (SOP) for fuel blending (BFLSP-SW-010-001SOP006 April 2021 Issue 1) which was in use at the time, the fuel mix should have been stored undercover in the bunker of NB4. There was no space in the bunker of NB4 as this area contained pallets of wrapped product. **NRW considers this a breach of permit condition 1.1.1 – C2 Management Systems- CCS3.**

**Action 1:** Operator is required to take steps set out in schedule 1 Regulation 36 enforcement notice served on Newbridge Energy Ltd 24.09.21.

Following this site inspection, an Environmental Permitting (England and Wales) Regulations 2016 Regulation 36 enforcement notice was served on the operator requiring them to take specified steps in relation to the above.

Two skips containing ash wastes were uncovered at the time of the site inspection. Environmental Permitting Technical Note 5/1(18), Final Draft dated 15/08/18 S4.10.3 states

“Bottom ash should be stored and disposed of in a manner to prevent the escape of dusty waste, i.e. in covered containers, purpose-built silos or undercover.”

**NRW considers this a breach of permit condition 2.3.1-Table S2.1(a) Environmental Permitting Technical Note 5/1(18), Final Draft dated 15/08/18-S4 10.3 (C4-Storage,Handling,Labelling and Segregation-CCS3).**

**Action 2:** Ensure skips containing ash wastes are covered and provide NRW with an update on what control measures have been put in place to ensure the skips containing ash wastes remain covered.
