4. Details of our assessment

1.1 General Management

Inspection of replacement hopper doors.

- Replacement doors are now fitted as an odour control measure. The doors are now in full working order but care must be taken to not overfeed the hopper causing the doors not to seat correctly. This could result in odour issues.
- Drainage upgrades appear to be working efficiently. This is particularly evident given the ability of the site to cope with the recent high volumes of rainfall. Foul drainage is now entirely separated from clean surface water drainage. The storage clamps containing beet, and triticale are now working as intended with no evidence of pollution following the extensive drainage works.
- Inspection of the drainage to the settlement pond prior to discharge shows no evidence of contamination.
- Engine is now running consistently at approximately 1.2MW electrical output.

3. Emissions and Monitoring

- Water in the settlement pond has been tested before release and is within permit limits.
- Odour levels on site are low and being appropriately managed
- Off site odour inspection showed no trace of odour between the site and sensitive receptors.

In general, pollution prevention measures instigated over the last 3 years appear to have significantly reduced risk to the environment and sensitive receptors. This is a much improved situation and is a welcome step forward in compliance.
