4. Details of our assessment

Many thanks for your time during the routine inspection on Wednesday 23rd September 2021. A Rees, J Lloyd and A Weedy from Natural Resources Wales met the operators of Upper Esgair and Gail Jenkins of Roger Parry & Partners on site at 11:00am.

All permit conditions were assessed during the inspection. The majority of conditions assessed were compliant, however some advisory comments were made to reach full compliance. Further information on

the advisory comments are detailed below:

1. We would advise the Site Entrance Identification Notice is made bigger. This must be easily readable from outside the site in daylight hours and should include the:
 - Emergency contact name and telephone number of the permit holder and/or operator
 - Statement that the site is permitted by Natural Resources Wales
 - Permit number (AP3733WS)
 - Natural Resources Wales incident line 0300 065 3000.
2. Please add the raw materials list and the list of emergency contacts to the Accident Management Plan.
3. The reviews for Energy, Raw Materials, Water and Waste are due in 2022. Please refer to the 'How to comply...' document for further guidance on the requirements of the reviews. Please submit the reviews to Natural Resources Wales by 04/11/2022.

Thank you for the submission of the Best Available Techniques (BAT) report. During the visit, it was mentioned we would clarify if the flat-deck unit complies with BAT 31. Based upon the information given, we believe the flat-deck unit complies with BAT 31 provided the unit and ventilation is carefully managed to ensure the production of dry, friable, and well-maintained litter. The conversion of the unit into a multi-tier aviary system with regular manure removal, as has been done with the other units, would comply fully with BAT 31.
