4. Details of our assessment

Q3 returns for 2021 (July, August, September)

Condition 4.2.3 states that:

Within 28 days of the end of the reporting period the operator shall....submit reports of the monitoring...with the conditions of this permit AB3591ZQ

The returns for Q3 were received on the 1st November and were therefore received late and outside of the reporting requirements. This has resulted in a C4 score which is a non-compliance which has no potential environmental impact.

The results for W1 were compliant with the permit.

Please ensure that monitoring returns are submitted within the timeframes required in the permit.

Schedule 5 Part A & B Notifications for Q3

On the 9th September Part A notification received advising that there had been a small leak from the scrubber return valve at 11am on the 9th September, which occurred when one of the engineering team went to tighten the valve and it came loose in his hand and the solution discharged in a shower like fashion. This had caused a small release into the drains on the yard and then into the interceptor.

Approx. loss of 50 litres of water solution which is water with 0.1ppm sodium hypochlorite/sodium hydroxide.

Measures taken at the time was to notify NRW and to use a chemical absorbent sock to reduce quantity entering the drains.

On the 30th September Part B notification received advising that a service had been booked for the scrubber to check all pipework following this release. The spill kits had also been replenished. No other measures taken.

ACTION:

- Please can you provide the dates of the service for the scrubber and whether any concerns were raised as a result of this service.
- What is the maintenance and service schedule for the scrubber - please provide documentation to show when the last service/maintenance was carried out.
- Please investigate the root cause into why the valve failed as it did. Have you had similar issues on other valves. Is the valve appropriate for its intended use. And were you aware of a fault on the valve prior to it failing.

Please provide the above by the 22nd November at the latest.
