Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales. Unaccompanied on site.

C2 - Management System and operating procedures

Under condition 1.1.1 a) the operator is required to operate activities in a manner that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents incidents...to the attention of the operator as a result of complaints”.

During the previous inspection it was confirmed that Ben Rees of Geotechnology was in the process of producing both an Environmental Management System (EMS) and a Fire Prevention and Mitigation Plan (FPMP) (as required under **condition 3.4**) with an action on the operator to submit both documents to NRW for review by 31st May 2021. These documents are yet to be received.

Action – Please submit the required documents above to Natural Resources Wales by 26th November 2021.

B1 - Engineering for the prevention and control of Emissions/B3 - Site drainage engineering/Site Security

Wastes were stored in an appropriate manner as required under the conditions of the permit and no wastes were stored outside of the permitted boundary in line with **Condition 2.4.1**.

Amenities F1 - Odour and F2 - Noise.

Under the conditions set under **Section 3** of the permit, emissions from the on site activities shall not give rise to pollution these include odours (**Conditions 3.2**) and Noise and Vibrations (**Conditions 3.3**) no odours were detected during the inspection.

No reports of noise or odours escaping the site have been received by Natural Resources Wales since the permit issue.
