### 4. Details of our assessment

During routine Audit of Newgale STW Rod Thomas was unable to establish the works was compliant with Conditions 5 & 6 Volume of discharge and dry weather flow, 8a & 8b Flow monitoring.

The site may be compliant but the information provided requires explanation to fully understand if compliance has been achieved.

Rod Thomas held a meeting with Sarah Mowlem & Jamie Dalton of DCWW on the 4th November 2021 to better understand the flow operations & flow monitoring at the site. Evidence was provided in the form of graphs and a narrative that confirmed the works is

now compliant for pass forward and dry weather flow.
