This Compliance Assessment Report has been generated following a review of the 2017 and 2018 waste returns for the permitted facility.

The 2017 waste returns contained no issues.

The 2018 waste returns contained a couple of issues which have been clarified with the site operator and are detailed below.

1. Waste was received where the EWC code and description did not match. This was found to be an oversight where the wrong code was assigned in error. Although a minor coding and classification issue, the site is permitted to accept either of the waste types identified as part of the issue so there would be no impact upon the permitted operations or risk to the environment.
2. Non-permitted waste (EWC code 17 03 02 (bituminous mixtures other than those mentioned in 17 03 01) described as 'minimal asphalt') was accepted at the site within Q4 of 2018 from within the areas of Conwy, Gwynedd and Denbighshire. This waste type is not listed within your permitted waste types as detailed within schedule 3 of your permit. The acceptance of non-permitted waste could potentially impact upon the surrounding environment. Guidance has been provided on waste acceptance.

In light of the above acceptance of a non-permitted waste type, a Compliance Classification Scheme category 3 non-compliance has been recorded against condition 2.8.1 of your site permit.

Please note that the quarter 1 2019 waste returns are required to be submitted to Natural Resources Wales by the 30th April 2019. Further guidance on waste returns is available via our website – www.naturalresourceswales.gov.uk.
