4. Details of our assessment

Compliance Assessment Report – Caerphilly Skip Hire (CWS) Limited

Officer Jonathan LEE in attendance of Caerphilly Skip Hire, Llanbradach to complete a routine compliance inspection of the environmental permit **EPR/EP3994LG**. Weather was warm and dry at the time of the inspection. Officer LEE met with site manager, Mr Alun Pitten.

Inspection

The site was operational, and an inspection of permitted area was completed. Transfer station activities were operating well and all incoming wastes following initial sorting were being stored in appropriate bays or sealed skips. Site drainage and surface infrastructure in good condition. It was noted that a crusher attachment was being used on one of the site excavators to process inert construction waste to a specific size grade. All waste being stored on the 'lower' yard on site was being stored in sealed skips as per permit conditions and awaiting onward recycling/disposal.

No issues within permitted area were noted at time of inspection. Compliance categories have been marked accordingly.

Quarterly waste returns have been submitted on time.
