4. Details of our assessment

On 08/09/2021 Natural Resources Wales Environment Officers Paul Latham and Natalie Wrangham attended Grove Golf Club to assess compliance with your abstraction permit.

We arrived at 12.35, the weather at this time was dry and warm. We were escorted to the abstraction point and pump-house by Mr David Stein.

The pump house and meter appeared well managed and maintained but there are some issues regarding recording of meter readings that require action, this is outlined below.

Permit ID 21/58/33/0011/R001 Section 8:

8.1 The license holder shall take and record readings of the meter specified in condition 7.1 at the same time of each month during the whole of the period during which abstraction is authorised or as otherwise approved in writing by NRW.

8.2 The license holder shall send to NRW a copy of the record required by condition 8.1 within 28 days of being so requested by NRW.

8.3 Each record shall be kept and be made available during all reasonable hours for inspection by NRW for at least 6 years.

ACTION: Recording of meter readings shall be carried out and documented as outlined in

section 8 of your permit. Documentation will be sent to paul.latham@naturalresourceswales.gov.uk on 01/10/2022 as evidence of actions taken to comply with your permit.
