4. Details of our assessment

Officer from Natural Resources Wales carried out a site visit following a report from the public of sewage entering the River Severn from a discharge pipe on the 22nd October 2021.

The discharge pipe was running slightly grey in colour, it appeared cloudy when the discharge entered the river but did not appear to have an effect due to the high level of dilution in the river. Whilst on site a Hafren Dyfrdwy operative came to take a water sample for analysis following instruction given earlier in the day.

Pool Quay Sewage Treatment Works has a Descriptive Consent permitting the discharge of sewage effluent.

Following the site visit NRW has been informed a cleanse has been carried out and measures put in place to increase supervision and maintenance of this site.

There was no evidence that the existing discharge is causing a polluting impact currently, however NRW would encourage Hafren Dyfrdwy to improve the asset by adding secondary treatment to provide an increased quality of the discharge, therefore reducing the impact to the receiving environment. Readings taken by HD on the day fall outside the expected range for that treatment system, current measures undertaken at the site will improve the effluent quality.

A desk top study has been carried out by NRW, at least two new houses have been built, this will add extra volume to the works.

1. Further information regarding your maintenance program for this site going forward.
2. Volume – Under section 5, Flow Measurement of the permit - provide evidence of flow data from this site, supply details of flow data in cubic meters per day for a period 1 month.
