4. Details of our assessment

On 10 November 2021 a site inspection was carried out at Derwen RRF by Sally Wakeford, accompanied on site by Stuart Hanford.

The site has built an extension to the existing building. This extension is within the current permit boundary. This part of the building houses loose RDF for loading onto walking floor containers to provide more space to move within the building.

The final two storage bays are awaiting the roofs for completion. The buildings along the side of the building have been completed with roofs to prevent run off into the surface water. The bays consist of 3-sided, solid roofed construction. No issues were noted with run off from any bay during the inspection.

Due to the changes on site, please provide a copy to NRW of the updated Management Plan and site plans for the site to include the new extension and storage bays. Please ensure it reflects the operations on site.

The building was clean, tidy and well organised. The large pile of oversized was to be shredded using a mobile shredder over the next couple of days, the waste would then be processed through the plant. This shredder is situated in a bay outside when not in use.

Access is required by bridge maintenance crew for the next year for the railway bridge outside the site. Derwen is providing a dedicated area for this activity to keep them separate from the permitted activities.

No non-compliances were identified during the site inspection.
