4. Details of our assessment

Site handover meeting and inspection 19th Oct 21

Review of actions from last CAR form:

- Interim Report for Vibrating Wire Piezometers provided (Ref 332510236/3504, dated 4th Oct 21) on 20th Oct.
- Update on Inclonometers. All five are now installed and associated specification provided. Monitoring commenced, NCC will be sending the data though when collated.

Separate discussion on soils audit - Arcadis appointed as NRW contractor, project ongoing.

Variation update – additional information sought in relation to air monitoring.

Site handover inspection including a general tour around the perimeter of the landform:

Tipping in progress in cell 4. There is a very large working area with potential to generate large volumes of leachate and suspended solids, along with little or no gas management infrastructure. **This is therefore considered to be a non-compliance in Operating techniques.** We discussed plans for reducing size of working area, managing run off, capping works, and to install / improve gas well coverage in the cell. Please provide CQA Plans / progress asap.

Cell3 hold periods are in place, as detailed in the VWP Report. Access to the asbestos mono cell / reception pad has also been removed.

Discussed gull / pest control measures. Bird control present during inspection.

An outstanding action from last CAR is to arrange a meeting to finalise GP09_18 Action Plan. We inspected this monitoring point series and associated headworks. Random inspection of nearby gas extraction wells along the south and west flanks revealed several which are at angles due to settlement of waste. The majority had no apparent flow. Please investigate further and provide proposals for improving extraction efficiency. Perched water in some wells may also be contributing to lateral migration.

Discussion and review of leachate management arrangements, including collection by

tanker from perimeter LDB rodding points.

Discussion of perimeter surface water drainage arrangements.

We also discussed site security, and previous instances of trespassing on site.
