4. Details of our assessment

A routine visit of the waste transfer station located at plot 10 Waterston Industrial Estate, Waterston, Milford Haven SA73 1DP and operated by TBS Skips Ltd was conducted on 03/11/2021.

NRW Waste Regulation Officer David Ellar conducted the visit and was accompanied around the site by Les Davies of TBS Skips.

TBS Skips operate under a SR2008 no.3 permit (EPR-VP3598FA).

The site was very clean, tidy, well organised and good waste separation was observed.

Technical Competent Management (TCM):

NRW believe David MacKay is the current TCM. The certificate for David's continued competency NRW have on file expired 19/12/20. NRW require evidence that the continued competency has been renewed?

Action: Please provide NRW a current continued Competency certificate for you TCM.

Fire Prevention and Mitigation Plan (FPMP):

It has been highlighted at our previous site visits the fire prevention mitigation and plan (FPMP) we have on file is still in draft form (dated September 2017) and not fully representative of your current operation. **This is a breach of condition 3.4.2 of your permit and has been recorded as a Category 3 noncompliance.** The last correspondence we had on this was when we visited on the 23/04/21 following a fire incident on site. One of our officers discussed this with yourself and you explained that dust suppression options were being revised and the FPMP was being updated.

Action: Please provide NRW an updated current copy of the FPMP.
