This was an unannounced inspection, however an email had been sent a day prior to Dave Youngs informing that I would be on site in the morning.

On arrival the site was locked and looked as though it was non-operational; there was no activity observed or heard whilst I was on site.

Waste Returns have been checked for the site - Null Returns were submitted in Q1 2017 and there are no other waste returns on our system for the site. During the last inspection the trial treatment of the waste from O'Connor Utilities was discussed; as waste had been accepted on site and treated the returns for the corresponding period will not be null returns. Can you submit the missing 2017 & 2018 Waste Returns (even if they are null returns) by 4 weeks from the issue of this CAR form - that is by 16th May 2019. If the returns are not submitted by this time then a breach of the relevant permit condition will be scored against the permit.
