A compliant inspection, however the following needs to be addressed:

During our inspection, you told us that you wish to apply for a variation to your permit in relation to the biomass boilers and bird numbers on site. We understand from our Permitting Team that this process is on-going.

In addition, we recommend for best practice it is good to colour code your drainage systems, typically using red for dirty water and blue for clean water. It would also be useful to have an emergency spill kit readily available on the yard. Dammit mats were suggested as a potential option to keep at hand in the event of a spillage incident.
