4. Details of our assessment

NRW officer Phil Harper visited Green Skips (Environmental) Ltd, Plot 10, Gaerwen Industrial Estate, Gaerwen, LL60 6HR on the 8th October 2021 at 14:15. Kevin Davies accompanied the site inspection.

Weather conditions were dry and overcast with sunny intervals.

At the time of the visit the site was operational.

Non- compliance with permit conditions

The following permit breaches have been witnessed during the inspection:

-

A1 Specified by permit

In December 2020 the permit was varied to include the use of a trommel and picking line. However, schedule 1 was also added which stipulates that all treatment will take place within a building. Currently a prefabricated building is on the site, but hasn't yet been erected. The operator has provided a lead time of three months for the construction of the building.

A **category 3 permit breach** with respect to **permit condition 2.1.1. "The operator is only authorised to carry out the activities specified in schedule 1 table S1.1 (the "activities")"** has been applied.

Action: The treatment of waste must take place within a building by the **7th February 2022**.

B4 Containment of stored materials

Segregated waste was stored in bays that had been constructed using concrete lego blocks. Bays were in good condition and the waste was contained within in each bay with no waste spilling out or overflowing.

F1 Odour

No odours on site or outside of the site boundary.

F2 Noise

Site was operational during the inspection, no excessive noise.

F3 Dust/fibres/particulates and litter

Ground conditions were damp at the time of the inspection. No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.
