4. Details of our assessment

On 12th November 2021 AIUK submitted a Schedule 5 Notification to Natural Resources Wales (NRW) informing NRW that AIUK's discharge to sewer had exceeded the emission limit value (ELV) on 8th November 2021.

The analysed total aluminium (Al) concentration was 2.7mg/L, +/-14%; the ELV is 2mg/L. Both the total and dissolved Al results were 2.7mg/L, inferring that there could have been a problem early on in the treatment process. A sample taken two and a half hours later gave a concentration of 0.18mg/L total Al.

The root cause has not been established. AIUK will investigate further and put any remedial actions in place.
