4. Details of our assessment

The 2021 Q3 returns for emissions to air and water were submitted to NRW on the 28th October 2021.

Emissions to Air

Particulate matter was recorded at 0.49mg/m³ with an uncertainty of 0.25mg/m³.

Emissions to Water

The temperature parameter has an ELV of 28°C. The returns show a minimum temperature of 14.6°C and a maximum of 16.8°C. Uncertainty for temperature is +/- 0.59°C. This is well below the ELV.

The pH parameter ELV is to be between 6 and 9. The returns show values ranging from 6.29 to 6.95. Uncertainty for pH is +/- 0.02pH. Which is within the ELVs.

The Ammonia parameter ELV is 7mg/l. Returns show values less than 0.2mg/l. Uncertainty is +/- 4.9%.

Total Suspended Solids ELV is 200mg/l. Returns range from 3.5mg/l to 8.3mg/l. Uncertainty is +/- 1.96%.

Do you know the reason for the result on the 29th September is double the previous months results?

After reviewing the documents, no emission limit values (ELV) had been breached. The operator is therefore compliant with their environmental permit.
