4. Details of our assessment

Quarter 3- 2021 Returns Review

Performance - Operating hours between 01/07/2021 and 30/09/2021 were 5928 hours with no period of abnormal operations recorded. There have been 0.5 hours of abnormal operation cumulative for the year to date.

Air Emissions - CO emission limit is now 150mg/m³ as a 10-minute average in line with the Industrial Emissions Directive Annex VI, Part 3.

Sampling Results - Emission Monitoring Survey was carried out between 2-6th August 2021 by ECL, who are MCERTS and UKAS accredited. The details of this report will be covered within the OMA report and supporting CAR form.

Permit Variation –

The Operator has submitted a Permit Variation for acceptance of dog faeces waste following NRW advice on EWC codes for this waste type. Following this a further request has come into permitting from Enfinium to also consider AHP as part of their variation application, following a contractual and commercial decision with Flintshire County Council. NRW have responded to this query.

Residues -

Bottom Ash - TOC limit is 0.94% (95th'ile). Loss of Ignition was 2.6%.

There are no non-compliances in respect to the above, and the site is compliant with the

permit requirements for the Q3 returns requirements in permit AB3092CV .
