Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

The Industrial Emissions Directive (IED) came into force on 7th January 2014 with the requirement to implement all relevant BAT conclusions as described in the Commission Implementing Decision. The Intensive Farming BAT conclusions were published on 21st February 2017 in the Official Journal of the European Union following a European Union wide review of BAT.

This variation incorporates the changes required by the Industrial Emissions Directive following a statutory review of permits in the intensive farming sector. This includes the amendment of the wording of several permit conditions relating to notifications, monitoring and reporting. At the same time the permit has been converted into the current EPR Permit format.

The schedules specify the changes made to the permit.
