Thank you for your application received on 31 March 2017. Unfortunately we need more information from you before we can continue working on it.

Please can you complete Part B2 section 3a of the application form, relating to relevant offences.

Although it has not been assessed yet, it is noted that the correct screening distances have not been used in your Ammonia Report. Assessments of air emissions in relation to Critical Levels/Loads should be carried out where there are:

- Special Areas of Conservation (SAC), Special Protection Areas (SPA) and Ramsar sites within 10km of the proposed installation and
- Sites of Special Scientific Interest (SSSI) within 5km of the proposed installation
- Any other designated sites including Ancient Woodlands or Local Wildlife Sites within 2km of the proposed installation

In your email of 31 March 2017, you stated that hard copies of the application would follow, but none have been received. Please could you forward a copy of the documents to me at the address below.
