Cargo Services contacted NRW on 25th April 2018 to advise that the current storage requirements for Celsa's EAF dust, as stipulated in the permit, were proving difficult to comply with. While they have the capacity to store approx. 1500t of bagged dust in a warehouse, further capacity can be restricted depending upon other activities. Consequently, permission is often requested for some EAF dust to be stored externally. This is only necessary for the period up to the time of despatch, this typically occurs every six weeks.

Cargo Services plan to submit a permit variation to seek such flexibility in the storage arrangements on a permanent basis.

It is noteworthy that the EAF dust storage bags are very robust and always sealed prior to despatch from Celsa. On no account should damaged bags be delivered to Cargo Services. In the event that damaged bags are identified they must be returned to Celsa without delay. External storage should only be located on hard standing with sealed drainage, and within the Cargo Services site boundary.

Permission for external storage is granted on the basis that;

- there is no increased potential for environmental impact compared with warehouse storage
- this is a temporary arrangement pending submission and subsequent determination of a variation application.
