NRW had already been advised of an earlier delay and permission had therefore been granted for storage of the EAF dust external to the warehouse until 30th November 2017 (CAR\_NRW0032464).

As the further delay is out of the control of Cargo Services, NRW is prepared to grant a further extension for the same arrangements, until Friday 15th December 2017 (inclusive).
