Air Emissions

Emissions of HCL from A1, A3, A4 and A5 are all below the emission limit of 10mg/m3.

Sewer emissions

No breaches recorded. Emissions to sewer from S1 had a recorded breach in January 2015. A value of 3.6 was reported for pH against the lower limit of 6. This has been previously breached in the last CAR Form dated 18/02/15.
