This CAR Form confirms receipt of a notification received under condition 5.1.1 for a release on the 12th January 2015. This instigated the implementation of the IQE Silicon Compounds Ltd Incident Investigation Form that triggered associated investigation and resulted in the identification of a fuse that had failed that is used to pump Sodium Hydroxide to increase levels of Ph in the effluent. The fuse has now been replaced and the pump restarted. **A category 4 non compliance has been scored for this breach.**

IQE is to investigate with the vendor to connect an alarm to trigger a pump failure.
