4. Details of our assessment

Review of monitoring returns 2021

Bio-aerosol monitoring was undertaken in accordance with Condition 3.7.1. The permit requires bioaerosol monitoring to be undertaken twice a year. NRW have reiterated that the monitoring should be spaced out across the year.

Table S3.1 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m³
- Aspergillus fumigatus - 500 cfu/m³
- Gram negative - 300 cfu/m³

Results from 12th August 2021 were received on 28th September 2021. Bio-aerosol concentrations were below the above limits at all sampling locations during this monitoring exercise.

Results from 6th October 2021 were received on 1st November 2021. Bio-aerosol concentrations were below the above limits at all sampling locations during this monitoring exercise
