Review of quarterly monitoring returns

Condition 4.2.3 requires that a report on emissions over the previous quarter shall be submitted within 28 days of the end of the reporting period. Quarter 3 (July - September 2021) returns were received on 18th November 2021. **The late submission has been scored a CCS4 breach of Condition 4.2.3.**

Action: Ensure future returns are submitted on time.

Monitoring was undertaken in accordance with Condition 3.5.1.

Emissions to sewer (flow) July to September 2021 - flow readings provided.

Efficacy data submitted shows pass for all months in Q3 2021.
