4. Details of our assessment

Review of monitoring returns 2021

Bio-aerosol monitoring was undertaken in accordance with Condition 3.5.1. The permit previously required bioaerosol monitoring to be undertaken twice a year. Following the Waste Treatment Bref the Permit was updated and reissued in June 2021. The requirement for bioaerosol monitoring has been amended to every six months. NRW have reiterated that the monitoring should be spaced out across the year.

Table S3.4 specifies limits for bio-aerosol concentrations as:

- Total bacteria (TB) - 1000 cfu/m³
- Aspergillus fumigatus (AF) - 500 cfu/m³

Results from 12th August 2021 were received on 28th September 2021. Bio-aerosol concentrations were below the above limits at all sampling locations during this monitoring exercise.

Results from 6th October 2021 were received on 1st November 2021. Bio-aerosol concentrations were below the above limits at all sampling locations during this monitoring exercise.
