4. Details of our assessment

Abril Waxes

EPR/BV5858IW

NRW received the quarterly returns for Abril Waxes on the 19th October 2021.

All criteria for emissions to Air and emissions to Sewer were satisfied and no further action is required.

NRW have also received a review of the Site Protection and Monitoring Program as requested by permit condition 4.1.8.

4.1.8 *The Operator shall maintain the Site Protection and Monitoring Programme (SPMP) submitted under condition 4.1.7, and shall carry out regular reviews of it. The results of such reviews and any changes made to the SPMP shall be reported to the Agency within 1 month of the review or change.*

The review highlighted an internal NCR associated with the deteriorating condition of the rendering on the inside of the bund. This was highlighted in a previous report; CAR_NRW0036898. No action has been undertaken since this was highlighted in the June 2018 audit (NCR 290). Plans have been discussed along with other large-scale safety and expansion projects scheduled to take place summer 2020 but postponed due to Covid travel ban. Engineers from Sweden are scheduled to visit site mid-October.

NRW accepts the review and the forthcoming engineering works. It is a requirement under permit condition 2.3.5 that “all plant and equipment used in operating the Permitted Installation, the failure of which could lead to an adverse impact on the environment, shall be maintained in good operating condition”. Abril should seek to remediate the rendering as soon as possible to ensure any potential future spills are contained.
