### 4. Details of our assessment

A routine unannounced site inspection was undertaken by Natural Resource Wales officers Ffion Quan (Waste Regulation Officer) accompanied by Kim Jones (Hazardous Waste Officer). Officers on site were met by Gary Griffiths, the highways operations manager.

The weather throughout the visit was dull and damp.

The landfill was inspected during the visit as it is post operational but not yet surrendered. The gates to the entrance of the closed landfill were locked and as seen in the photograph below. Some materials are being stored on the landfill area, other than that, no other waste was stored.



Our records show that Penrhos Depot Landfill received the closure report on the 20 September 2010 and unsure of your attentions to surrender. Please find attached the guidance on how to surrender your environmental permit - [RGN 9 Surrender \(cyfoethnaturiol.cymru\)](#).
