4. Details of our assessment

This inspection was a pre-arranged visit to the operational site by Ian Oakes and Paul Challender and comprised two distinct areas, Control of Major Accident Hazards (COMAH) and Environmental Permitting Regulations (EPR) . COMAH flood preparedness was covered by Ian Oakes and the outcomes from this portion of the visit will be communicated separately.

FMC Agro Limited was represented by Alan Edge the EHS Manager, Garry Clarke the Plant Manager and Carl Rowe the EMEA EHS Lead.

The visit also functioned as a handover inspection visit to transfer EPR based regulation from Ian Oakes to the new regulating officer, Paul Challender. This Compliance Assessment Report covers EPR aspects only. A presentation and familiarisation tour of the facility was given to the new regulating officer and permitted emission points were viewed and discussed including surface water discharge procedures and discussions with laboratory staff regarding the surface water testing and authorisation regime.

Inspecting officers were also made aware of future improvements of containment infrastructure and planned replacement of vessels and bunds that are approaching planned end of life. In addition, site's MCERTs emission to air emission point was viewed to support the ongoing Operator Monitoring Assessment (OMA). Results of the OMA will be communicated separately in due course.
