## 4. Details of our assessment

Review of Q2 April-June 2021 monitoring returns and Schedule 5 notifications.

This monitoring data was initially submitted to NRW on 06.08.21. Permit condition 4.2.3 requires that quarterly returns are submitted to NRW within 28 days of the end of the reporting period. NRW considers this a breach of condition 4.2.3 (G4-CCS4).

Action 1: Please ensure monitoring returns are submitted to NRW within 28 days of the end of the reporting period.

The operator submitted updated / amended Q2 data to NRW on 09.09.21.

Leachate - condition 2.7.1-Table S3.1

During Q2 (April-June 2021) leachate levels between 0.72m and 29.74m were recorded versus a compliance limit of 2m.

With reference to schedule 5 notifications HAF 288 (April) 290 (May) and 291 (June), there were 7 instances where the recorded leachate level was >2m. NRW considers this a breach of permit condition 2.7.1-The limit for the level of leachate listed in schedule 3, table S3.1 (2m), shall not be exceeded (B1-CCS3).

Action 2: Operator to ensure pumps and ancillary equipment are well maintained.

During Q2 (April-June 2021), 5525 m<sup>3</sup> of leachate was tankered offsite for treatment.

With reference to schedule 5 notifications HAF288, 290 and 291, the operator states that high leachate levels in LMP2AR are believed to be due to perched leachate. To help address the perched leachate, the operator installed a new electrical cable (June 2021) and an Ebox automated pumping panel (July 2021). Over the next few months, the operator expects to see a reduction in leachate levels in this chamber as the perched leachate is pumped down.

The operator states that raised leachate levels in LMP4b are also due to perched leachate. To address this, the operator is planning to install a pneumatic pump in this chamber and monitor its impact on leachate levels in comparison with leachate levels in LC4.

Leachate-other monitoring requirements-condition 3.5.1 (a)-Table S3.9

The operator provided data for leachate-other monitoring requirements as required by condition 3.5.1 (a).

#### Perimeter gas- condition 3.1.7 -Tables S3.6 and S3.7

With reference to schedule 5 notifications HAF 287, 289 and 292, there were 26 instances during Q2 where methane levels in perimeter gas wells exceeded the 1% compliance limit. NRW considers this a breach of permit condition 3.1.7- The limits for landfill gas set out in schedule 3, Table S3.6 and S3.7 shall not be exceeded (E1-CCS3).

HAF287 for methane levels in GB01GB04a,GB04b,GB06a,GB07a,GB07b and GB12 ranging between 8.1- 35.3 % versus a 1% compliance limit.

HAF 289 for methane levels in GB01,GB04b,GB06a,GB07a,GB07b,GB09,GB12,HA 10(B),HA10 (M) and HA10 (T) ranging between 2.1-40.8% versus a 1% compliance limit.

HAF 292 for methane levels in GB01,GB04a,GB04b,GB06a,GB07a,GB07b,GB09,GB12 and HA10(M) ranging between 1.1-33.5% versus a 1% compliance limit.

Historically, these perimeter gas wells have demonstrated elevated methane levels. All perimeter gas wells show very low or negative relative pressure. The perimeter gas wells are subject to the Landfill Gas Management Plan.

Action 3: Operator to continue to follow landfill gas management plan and monitor closely.

#### In waste landfill gas- condition 3.5.1(d)-Table S3.8

The operator has provided monthly in waste landfill gas data as required by condition 3.5.1(d).

#### Groundwater quality and levels-condition 3.5.1(c) -Tables S3.5 and S3.11

The operator has provided data for groundwater quality and groundwater levels.

All groundwater quality samples are within compliance limits apart from HA12C(B) which shows a slightly elevated result for Chloride -230 mg/l versus a compliance limit of 200 mg/l. NRW considers this a breach of permit condition 3.5.1(d) (E2-CCS3). NRW has not received a schedule 5 notification for this breach.

Action 4: Please submit a completed S5 notification for the elevated chloride result referred

to above.

Point source emissions to water (other than sewer)-condition 3.1-Table S3.3

The operator has provided surface water quality data as required by condition 3.1 -table S3.3. These samples are within the compliance limits specified in table S3.3.
