4. Details of our assessment

A Water Resources compliance inspection was carried out by Heidi Markham from the Ceredigion Environment Team on 19th August 2021.

Source of Supply and Point of Abstraction

The water is abstracted from an un-named tributary of the Afon Mynach at Aberbodcoll, Devil's Bridge, National Grid Reference SN 75104 76392. The abstraction point and fish easement can be seen in Figure 1 below.

No issues were identified.

Means of Abstraction

The water is abstracted by intake works and a gravity feed pipe of an internal diameter not exceeding 280 millimetres.

No issues were identified.

Purpose of Abstraction

All water is abstracted for the production of power.

No issues were identified.

Means of Measurement

The Licence Holder shall determine the quantity of water abstracted by reference to the kilowatt-hours meter. The turbine and meter are housed in the turbine house. An inspection was carried out from the doorway to the turbine house, shown in Figure 2 below.

All water abstracted is returned to the un-named tributary of the Afon Mynach as National Grid Reference SN 74991 76494. The outfall is shown in Figure 3 below.
