Permit Condition 4.1.4 Fugitive Emissions Review

The ongoing controls on fugitive emissions appear adequate and these should continue to be enforced.

Permit Condition 4.1.5 EMS review of targets

The reported year on year reductions in closed system oil loss and general waste tonnage are commendable. The ongoing small percentage, but none the less valuable, reductions in gas consumption is also good.

It is noted that in previous years targets have also been set for other parameters such as water and hydraulic oil usage, but these have not been reported on for 2015.

Celsa should continue to set realistic targets that promote continued reductions for a full suite of parameters.

Permit Condition 2.7.2

The reported annual energy management system update provides evidence of existing and new initiatives that are being adopted to realise year on year improvements in overall energy efficiency. Celsa are to be commended for this approach.
