Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation and consolidation of an environmental permit.

The installation is operated by a partnership of Mr R Watkins, Mrs P Watkins and Mr B Watkins who trade as B Watkins & Son and comprises five poultry houses accommodating 270,000 broiler chickens, reared for meat production.

Dolau House Poultry Farm is switching from a fossil fuel (gas) dependant heating system to a biomass boiler to heat the poultry houses.

One 995 kW_{th} boiler will be housed in a separate purpose built and self-contained boiler room. The fuel used will be virgin wood chip or biomass wood pellets delivered to site and stored in the fuel store attached to the boiler room. The store has capacity of approximately 100t. Total annual throughput of the installation is estimated at approximately 1,000t.

Virgin woodchip/pellet is bulk delivered into the store and heaped onto the boiler automated delivery auger by means of a telehandler and bucket.

The re-issued permit consolidates all previous notices and the base permit issued in 2008. The re-issue of the permit follows a request from the operator for consolidation.

The schedules specify the changes made to the original permit.
