1. Accident Management Plan - It may be beneficial to put a copy of the document alongside the drainage plan in the gatehouse for any employees, contractors etc to refer to if they require to.
2. It came to our attention that the dirty water tanks on the Site layout/drainage plan at the back of the permit are not positioned in the correct place. This is a minor point, however this will need to be changed and re-issued as another variation to the permit. We will raise this with our permitting team who will be in contact with you to revise the plan.
