CAR Form following site visit on 2nd September 2016

This CAR Form acknowledges receipt of the 2015 Annual review of Environmental Monitoring in March 2016 with the following comments:

On 25th August 2009 the Environment Agency (now Natural Resource Wales) varied the permit so that the site would be operated in line with the requirements of the Closure Report received in July 2008 Report Number 664.1/0/078. Appendix 6 of the report sets out the requirements of the Aftercare Monitoring Plan.

Section 8 of the 2015 Annual Report has the following actions:

1. The integrity of the site boundary should be checked to ensure members of the public can not gain access.
2. Vegetation in the vicinity of several sampling points requires routine clearance to enable continual safe access.
3. The AMP suggested leachate breakout monitoring should comprise six monthly site walkovers, particularly around the embankments of lagoon 12 and 25. This needs to be implemented.
4. There should be an annual walk-over each springtime to look for evidence of shallow translational slips along the embankment of Lagoon 12.

ACTION: Tata to ensure that the actions in the 2015 report are implemented through their own EMS and associated procedures.

ACTION: NRW / Tata to confirm and agree the permit boundaries for the permit EPR/HP3899FC (EAWML 30009) and EPR/GP3331SV.
