Complaint received on 27th July 2015

A complaint was received to NRW regarding a strong odour emanating from the PG Gelatins site on Gwaelod-Y-Garth Road. On arrival on site DW detected a strong odour at the site boundary that is associated with the sludge tanker. DW met with PB Gelatin, who were already on site, to discuss what led to the odour release. PB Gelatin informed DW that the driver of the Envirocycle sludge tanker did not connect the pipework to the filter system that reduces the odour concentration. This led to a release of odorous air from the tanker directly in to the atmosphere and led to the subsequent complaints.

There are two breaches of the permit that occurred:

- 1) The odour release has been scored as a category 3 breach of condition 3.4.1 of the permit. The odour was strong at the site boundary and at the local business premises where the complaints were made.
- 2) Not following the sites EMS and associated procedures has been scored as a category 3 breach of condition 1.1.1. The second breach of the permit is in regard to the environment management system that has procedures in place for the unloading of the sludge storage tank into the Envirocycle tanker that transports the sludge from the site.
