1. Complaints received to NRW and OMP

There have been complaints from local businesses with regards to odour from PB Gelatins but the odour has been short lived and dispersed quickly. On the day of the visit a complaint was received and myself and Alan Fitzpatrick investigated the complaint within approximately 30 minutes but could not substantiate the complaint.

The system set up that contacts PB Gelatins as soon as a call is made to ICC is working well and enabling PB Gelatin staff to investigate the complaint quickly and be visible to the public. Myself and Alan investigated potential sources of odour on site and noted the skip drainage and the old farm as potential sources.

ACTION: PB Gelatin to clear bone collected in drains around the waste skip and ensure a thorough wash down is undertaken after each collection, this will include checking the drains are running clear to avoid a build of potentially odorous material.

ACTION: PB Gelatin to ensure the doors to the old farm are kept shut when not required to be open, this will help avoid a 'wind tunnel' effect through the building as well as improve security on site.

ACTION: PB Gelatin to clear the drains around the transfer area at the side of the old farm. Visual checks should be made during the cleaning of the area to avoid the build of bone in the drains and avoid potential odours.

2. Improvement condition update

IC3 – Preventative maintenance plan – This has now been received and under review by NRW.
IC4 – Pipework moved – This has been extended to the 30th September 2015. PB Gelatins have discussed the plans for this area with NRW and are considering putting additional bunds around the pipework instead of moving the pipes.

IC5 – Tertiary bunding – date remains as 30th December 2015.

IC6 – Hard standing – has previously been extended until the 1st May in the last CAR form.

IC14 - Drains painted – this has been actioned by PB Gelatin and are waiting for contractor to complete the works.

3. Annual returns and other permit requirements

PB Gelatin are in the process of submitting their annual returns as well as their pollution inventory returns.

This CAR form also confirms that the monitoring of suspended solids and COD as required in Table S3.3 for the *Process monitoring requirements* be changed to fortnightly. This is in line with the monitoring undertaken by Welsh Water in respect of their discharge consent.
