4. Details of our assessment

NRW officers Phil Harper and Cathrine Kiely visited Llandegai Civic Amenity Site, Llandegai Industrial Estate, Bangor, Gwynedd, LL57 4YH on the 16th November 2021.

Weather conditions were bright, dry and sunny. The site was operational at the time of the visit.

The inspection was accompanied by Chris Thomas the site manager.

This was the first site inspection following extensive engineering works to improve site efficiency and to better implement the circular economy within Gwynedd.

Notable improvements have been made to site infrastructure. The site was very clean and tidy at the time of the visit.



B4 Containment of Stored Materials

All materials on site were contained appropriately. No loose waste was present on site. Road

sweepings were contained appropriately within their allocated bay.



C1 Staff Competency/ training

During the inspection officers were informed that the Technically Competent Manager for the site was Steven Edwards who is currently the Technically Competent Manager for all permitted waste sites throughout Gwynedd.

Please note that page 37 of the How to comply with your environmental permit document states an expectation that the Technical Competent Manager will attend an operational permitted site for a minimum duration of one hour per week. Natural Resources Wales is concerned that a single person may not be able to provide this level of supervision to all sites that are operated by Gwynedd County Council.

Action: Review the supervision for all sites operated by Gwynedd County Council and appoint sufficient Technically Competent Managers to sites to ensure the required level of supervision is achieved.

As per permit condition 1.5.1 The Technically Competent Manager for Llandegai CA site must be named and evidence of WAMITAB qualification level 4 must be provided to NRW by the **17th December 2021**.
