4. Details of our assessment

As a part of Natural Resources Wales' (NRW) routine assessments for compliance the waste returns for the period covering Q3 2020 to Q2 2021 For Rhydeinon were reviewed.

During the review of the waste returns, it was identified you were accepting 15 01 04 Tin

Cans, 16 02 13 Computer Monitors, 16 06 01 Lead acid batteries, 17 02 01 Wood, which are not an authorised waste type on your permit. You have previously been scored for this issue on both CAR_NRW0037543 and CAR_NRW0038415.

The operator was contacted and explained that as per the last discussion with NRW, the system had been updated to remove the unauthorised codes therefore all the paperwork is correct. However, the NRW reporting procedures had not been amended therefore the incorrect codes were still being reported. All the backing data is correct on the system but on the summary section the final EWC codes had not been amended.

The issue has now been rectified and all software systems have been amended correctly. All incorrect waste returns have been resubmitted.
