Thank you for your time during the inspection. The inspection found that you were not compliant with your permit. The breaches are noted above. We require the following to be presented to us by 01/08/2018:

- As discussed on site, we require that collision barriers are put in place around the vulnerable sides of the feed silos to meet criteria in condition 3.2 in your permit as at a present they are exposed to vehicles.

We consider these to be minor breaches, however we require action to be taken. Please be aware that continued breaches may result in enforcement action and expelling from the assurance scheme.

Whilst on site, we were also made aware that the number of sheds, bird places and site plan in your permit is inaccurate as an old application is included in the permit despite not being built. We are in discussions as to the best way forward for yourselves in regards to this finding.
