Site Inspection 2017

A planned inspection was carried out on 7/6/17 in order to check surface conditions.

Haul road damping and wheel wash were operational. All surfaces inspected were well covered by vegetation and there were no signs of erosion or animal burrow damage.

No RWE operations were taking place at the time of the inspection as only the short tipping area is now operational.

Consideration should be given to producing a closure report for the landfill to start the process of moving the site into the aftercare phase.

Monitoring reports

Six monthly and annual monitoring data (condition 4.2.1) for H2 2016 and H1 2017 have been reviewed and no breaches identified.
