### **2015 Pollution Release and Transfer Register (PRTR) and National Atmospheric Emission Inventory (NAEI) Reporting**

I am writing to inform you that NRW will no longer be collecting Pollution Inventory data via the online PIEDC system. Instead we will collect emission data required for the European Release and Transfer Register (E-PRTR) and the data required for the National Atmospheric Emissions Inventory (NAEI).

The requirement to report to EPRTR is statutory therefore we are using a legal notice to gather the necessary information. Enclosed is a notice that we serve in exercise of our powers under regulation 60(1) of the Environmental Permitting (England and Wales) Regulations 2010. The notice requires the submission of information specified in the attached PRTR and NAEI schedule, for each site detailed for the calendar year 2015 onwards. The schedule asks for information on annual mass releases to air and water, and off site transfers of waste and of specified substances in waste water.

You need to complete your return using the online Ricardo PRTR Data Management System. A password and national ID will be automatically emailed to you at the e mail address [amy.lavisher@rwe.com](mailto:amy.lavisher@rwe.com).

The system can be accessed using the link <http://prtr.defra.gov.uk/data-entry-system/>

The reporting system will be available online from the 25<sup>th</sup> April 2016 and the deadline for submitting 2015 data will be the **10<sup>th</sup> June 2016**. For subsequent years, the deadline will be 31<sup>st</sup> March of the year following that being reported. The attached notice will only be reissued when changes are made to the reporting requirements.
